

## MyAAT registration - rules of entry

1. You must create a new MyAAT account through the AAT website [www.aat.org.uk](http://www.aat.org.uk).
2. Entry is not permitted for any MyAAT accounts already created or created outside of the relevant date period for this competition which is 01/10/2011 – 31/10/2011.
3. This competition will run for the period stated in rule point 2 and a winner selected at random within five days of the month end to select a winner.
4. Entry into this competition is restricted to AAT full or fellow members (MAAT or FMAAT) only.
5. The winner will be drawn at random from those MyAAT accounts created.
6. The winner will receive an iPod shuffle dispatched by post.

1. Entrants must create a MyAAT account through the AAT website of [www.aat.org.uk](http://www.aat.org.uk). The account must be registered to an AAT full or fellow member that hasn't previously created a MyAAT account under this name or membership number.
2. The competition runs for a calendar month period from 1 October 2011 and will close at midnight on 31 October 2011. All account registrations must have been completed by this date in order to be included in the competition.
3. AAT reserves the right to refuse any entry in its sole discretion. AAT also reserves the right at any time during the competition to disqualify any entry when it believes in its sole discretion that the entrant has: (i) infringed any of the regulatory membership requirements; (ii) breached AAT's code of ethics.
4. The winner will be notified via email or telephone no later than five working days after the competition closes.
5. The overall winner will receive an iPod shuffle 2GB (no cash alternative is offered).
