The Tax Agent Strategy aims to transform the relationship between HM Revenue & Customs (HMRC) and agents by:

- aligning HMRC and agent processes where possible and enabling agents to carry out some transactions for themselves with minimal HMRC involvement
- eliminating duplication and reworking making it easier for agents to do business with HMRC and reducing costs
- supporting agents in improving services for their clients and, where needed, tackling the small minority of agents with poor performance more effectively
- working closely with the agent representative bodies on the development of Agent and Client Statistics

The presentations will also include a talk about what HMRC is doing to improve the authorisation (Form 64-8) process and an overview of agent services available from HMRC.
